



## **Terms and Conditions – Wiser Bridge Consultants**

### **1. Purpose of the Collaboration**

This document defines the framework for the participation of authorized Wiser Bridge Consultants (or Promoters), specifically regarding the identification and referral of potential clients for the brand's private and personalized services.

The Consultant operates independently, with no employment relationship or hierarchical subordination to the company.

### **2. Nature of the Activity**

The Consultant's main role is to identify qualified leads seeking solutions such as:

Fiat to digital asset conversions (e.g., EUR ↔ USDT)

Capital legalization support

Real estate transactions using crypto

All operations are exclusively conducted by the Wiser Bridge team.

Consultants are not authorized to execute, receive, or manage any funds on behalf of the client.

### **3. Commissions and Payments**

The Consultant is entitled to receive up to 50% of the custom margin applied to each successfully completed operation referred by them.

The final commission amount is defined on a case-by-case basis, subject to Wiser Bridge's internal approval.

Payouts are issued only after:

The operation is completed

Client payment is confirmed

An official invoice is generated by the company

### **4. Confidentiality and Discretion**

The Consultant agrees to maintain strict confidentiality regarding all data, contacts, documents, methods, and internal structures used by Wiser Bridge.

It is strictly prohibited to share any internal content, data, or screenshots with third parties, clients, or on public/private platforms without prior written consent.

### **5. Use of Brand and Image**

Consultants are not allowed to:

Use the Wiser Bridge or WinWiseTrading logo, name, or visual identity without permission

Publicly present themselves as official representatives of the brand

Create unauthorized websites, social pages, campaigns, or content

All communication must be private and personalized, based on approved materials and internal guidance.

### **6. Limitation of Responsibility**

Consultants must not:

Present themselves as managers, partners, or legal representatives of Wiser Bridge

Guarantee returns, timeframes, or specific outcomes

Provide legal, financial, or tax advice

Any misleading statements or actions that compromise the brand may result in the immediate termination of collaboration.

### **7. Termination of Collaboration**

Wiser Bridge reserves the right to terminate a Consultant's collaboration at any time, without prior notice, in the event of:

Breach of trust

Improper exposure

Conduct that conflicts with the brand's values
